## PROMULGATION ORDER

From: Commanding Officer, Naval Air Station, Key West

To: Naval Air Station, Key West Morale, Welfare and Recreation

Subj: AMENDED SUSPENDED OPERATIONS IN MWR RV PARK, CAMPGROUNDS,

VACATION RENTALS AND MARINAS

Ref: (a) Promulgation Order 1710 Ser N01J/177 of 19 Mar 20

(b) Department of Defense Instruction 6200.3

(c) Commander, Navy Region Southeast Health Protection Guidance

(d) U.S. Northern Command Fragmentary Order 20-019.013

- 1. This Promulgation Order amends reference (a) and provides additional guidance on reduction and restriction of the Morale, Welfare and Recreation (MWR) Recreation Vehicle (RV) Park, Campgrounds, Vacation Rental Townhomes, and Marinas (collectively, "Recreational and Lodging Facilities").
- 2. Naval Air Station (NAS), Key West remains fully operational to support the Fleet, warfighters, and the military community on board the installation. Veterans, Retirees, Prisoners of War, and Purple Heart recipients are important members of our community. My appreciation for their years of service and dedication to this nation is a significant factor when weighed against the continued health and safety of our base operations and available resources/medical services both on base and in the civilian community.
- 3. In accordance with references (b) and (c), and ordered by reference (d), NAS Key West will maintain a Health Protection Condition (HPCON) Charlie Minus status. As directed by reference (d), NAS Key West will align itself with policies and restrictions set by the City of Key West and Monroe County.
- 4. As a preventative measure, the following are hereby ordered for all MWR Recreational and Lodging Facilities:
- a. <u>Gym.</u> Beginning Monday, March 23, 2020, the MWR Boca Chica Fitness Center will be open to Active Duty service members only. No more than 10 individuals are permitted in the facility.
- b. <u>Beaches</u>. Due to the size and shape of the beaches available onboard NAS Key West, and the ability to safely engage in social distancing, the Boca Chica Marina beach shall be closed.

Subj: AMENDED SUSPENDED OPERTATIONS IN MWR RV PARK, CAMPGROUNDS, VACATION RENTALS AND MARINAS

The Truman Annex beach shall remain open, with orders to ensure patrons remain at least 10 feet from each other. The inability to manage the beach usage by patrons will result in its immediate closure.

c. <u>Marina</u>. No new vessels will be permitted in the Marina. Vessels currently occupying a reserved slip in the Marina, who depart the Marina at any time, shall be denied re-entry. Vessels which have a reserved slip, which are currently departed and have not returned as of 1800 on Wednesday, March 25, 2020, will be denied re-entry.

## d. RV Park

- (1) Current reservations for MWR RV Park patrons shall be canceled. To ensure an orderly and well-managed departure, patrons are directed to leave NAS Key West in the following sequence:
- (a) Any reservation with a departure date of March 23 to April 1, 2020 shall leave the RV Park no later than 1800 on Monday, March 23, 2020.
- (b) Any reservation with a departure date of April 2 to April 23, 2020 shall leave the RV Park no later than 1800 on Tuesday, March 24, 2020.
- (c) Any reservation with a departure date of April 24, 2020 or after shall leave the RV Park no later than 1800 on Wednesday, March 25, 2020.
- (2) Active Duty military and civilian employees in direct support of NAS Key West operations are exempt.
- (3) Individuals are encouraged to depart on the day directed above, but may leave sooner. Coordination with the RV Park Office, appropriate resource management, and patience during this process is appreciated.
- 5. Authority to deviate is withheld and reserved by the CO.
- 6. This order shall be effective immediately and stay in effect until modified or terminated.
